- Income-based Jobseeker's Allowance
- Income-related Employment Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit, provided you are not also entitled to Working Tax Credit, and have an annual gross income, of no more than £16,190
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit

Guidance for applying for Uniform Grant:

- Secondary school uniform grants (and free school meals) are only available to children whose parents/guardians receive one or more of the following support payments:
 - Universal Credit, provided they have an annual net earned income not exceeding £7,400 (£616.67 per mnth)
 - Income Support (IS);
 - Income Based Job Seekers Allowance (IBJSA);
 - An income related Employment and Support Allowance (ESA ir);
 - Support under Part VI of the Immigration and Asylum Act 1999;
 - Child Tax Credit, provided parents are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190, as assessed by HMRC.
 - · Guarantee element of State Pension Credit.
 - Working Tax Credit run-on paid for 4 weeks after they stop qualifying for Working Tax Credit
- 2) No other category of support payment or combination of Tax Credits qualifies for secondary school uniform grant.
- 3) Grants will be paid when Children are in Year 7 plus either Year 9 or Year 10 from September 2020. If a grant is paid in Year 9, an application will not be accepted when the child moves in to Year 10.
- 4) Only one payment can be made for the school year September 2020 to July 2021.
- 5) Applications will be accepted between 1 June 2020 and 13 July 2021. Grants will be issued in the form of Skoolkit vouchers, (£40) by the 3rd of July 20.
