# Purpose of the policy

The centre is committed to ensuring that the exams management and administration process is run effectively and efficiently and in compliance with the published JCQ regulations and awarding body requirements.

This exam policy will ensure that:

- all aspects of the centre's exam process is documented, supporting the exams contingency plan, and other relevant exams-related policies, procedures and plans are signposted
- the workforce is well informed and supported to
- all centre staff involved in the exams process clearly understand their roles and responsibilities
- all exams and assessments are conducted in according to JCQ and awarding body regulations, guidance and instructions, thus maintaining the integrity and security of the exam/assessment system at all times
- "... The integrity and security of the examination/assessment system is maintained at all times and is not brought into disrepute." [JCQ General Regulations for Approved Centres (GR) 1]
- Exam candidates understand the exams process and what is expected of them

This policy is reviewed annually to ensure ways of working in the centre are accurately reflected and that exams and assessments are conducted to current JCQ (and awarding body) regulations, instructions and guidance.

This policy will be communicated to all relevant centre staff.

SLT, Heads of Departments and relevant staff will be given a copy of the Policy.

Relevant information contained in this policy is made accessible to the attention of the candidates by issuing Examination Booklet, Review of marking information and Guidance for Examinations

# Roles and responsibilities overview

"The head of centre is the individual who is accountable to the awarding bodies for ensuring that the centre is complaint with the published JCQ regulations and awarding body requirements in order to ensure the security and integrity of the examinations/assessments at all times.

The examinations officer is the person appointed by the head of centre to act on behalf of, and be the main point of contact for, the centre in matters relating to the general administration of awarding body examinations and assessments,

The head of centre may not appoint themselves as the examination officer. A head of centre and an examinations officer are two distinct and separate roles. [GR 2]

#### **Head of centre**

 Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:

**General regulations for approved centres** (GR)

<u>Instructions for conducting examinations</u> (ICE)

Access Arrangements and Reasonable Adjustments (AA)

<u>Suspected Malpractice in Examinations and Assessments</u> (SMEA)

<u>Instructions for conducting non-examination assessments</u> (NEA) (and the instructions for conducting controlled coursework)

A quide to the special consideration process (SC)

- Ensures the centre has appropriate accommodation to support the size of the cohorts being taught including appropriate accommodation for candidates requiring access arrangements for exams and assessment
- Takes responsibility for responding to National Centre Number Register Annual Update (administered on behalf of the JCQ member awarding bodies by OCR) ocr/org.uk/administration/stage-1-preparation/ncn-annual-update/) is responded to by the end of October each year confirming they are both aware of and adhering to the latest version of the JCQ regulations and signs and returns the head of centre's declaration which is then kept on file for inspection purposes

The signed copy of the 2020/21 declaration Policy is available from Exams Office

- Ensures the relevant senior leader(s), the examinations officer and the SENCo to receive appropriate training and support in order to facilitate the effective delivery of examinations and assessments within the centre, and ensure compliance with the published JCQ regulations
- Appoints a SENCo who will determine appropriate arrangements for candidates with learning difficulties and disabilities
- Ensures the exams officer (EO) receives appropriate support from relevant centre staff and
  enables the EO to attend appropriate training and other events in order to facilitate the
  effective delivery of exams and assessments within the centre (as example, EO networking
  events and relevant events offered by awarding bodies, MIS providers and other external
  providers)
- Ensures a named member of staff acts as the Special Educational Needs Co-ordinator (SENCo)
- Ensures centre staff are supported and appropriately trained to undertake key tasks within the exams process
- Ensures centre staff undertake key tasks within the exams process and meet internal deadlines set by the EO
- Ensures that a teacher who teaches the subject being examined, or a senior member of teaching staff who has had overall responsibility for the subject department and/or preparing the candidates for the examination, is not an invigilator during the timetabled written examination or on-screen test
- Ensures confidentiality and security within the examination process is compliant with and managed according to JCQ and awarding body regulations, guidance and instructions including
  - the location of the centre's secure storage facility in a secure room solely assigned to examinations for the purpose of administering secure examination materials
  - appropriate arrangements are in place to ensure that confidential materials are only delivered to authorised members of centre staff
  - access to the secure room and secure storage facility is restricted to the authorised 2-4 keyholders
  - Through taking an ethical and working proactively to avoid malpractice among students and staff takes all reasonable steps to prevent the occurrence of any

- malpractice/maladministration before, during the course of and after examinations have taken place
- the relevant awarding body is immediately informed if the security of question papers or confidential supporting instructions is put at risk
- that arrangements are in place to check that the correct question paper packets are opened by authorised members of centre staff
- Takes all reasonable steps to prevent the occurrence of any malpractice (which includes maladministration) before, during the course of and after examinations have taken place
- Ensures irregularities are investigated and informs the awarding bodies of any cases of alleged, suspected or actual incidents of malpractice or maladministration, involving a candidate or a member of staff, are reported to the awarding body immediately
- Ensures risks to the exam process are assessed and appropriate risk management processes/contingency plans are in place (that allow the head of centre to act immediately in the event of an emergency or staff absence)
- Advises on Appeals and re-marks

# **Exam Contingency Plan**

Policy available from Exams Office - The Examination Contingency Week 28 June 2021 – 16 July 2021.

This date is set aside for any major incidents that occur during the examination series, an exam may be rescheduled to another date within the published timetable. An examination would be re-scheduled only in extremely rate and exceptional circumstances. Once incident which may result in a change of an examination date would be if the security of an examination paper was breached. All students should be available up to and including 16 July 2021

 Ensures required internal appeals procedures are in place and drawn to the attention of candidates and (where relevant) their parents/carers

# **Internal Appeals Procedures**

The centre will before submitting marks to the awarding body inform candidates of their centre assessed marks and allow a candidate to request a review of the centre's marking and have. Policy available from Exams Office

The Centre has in place for inspection purposes and ensure candidates and their parents/carers are aware of a written appeals procedure to manage disputes when a candidate disagrees with a centre decision not to support a clerical re-check, a review of marking, a review of moderation or an appeal. Policy available in Exams Office

 Ensures the centre's disability policy demonstrating the centre's compliance with the relevant legislation is a place and details the processes followed in respect of identifying the need for, requesting and implementing access arrangements

#### Access arrangements policy

Policy available from Exams Office

- Ensures the relevant awarding bodies are informed of any Conflict of Interest where
  - A member of centre staff taking a qualification at the centre which includes internally assessed components/units (taking at the centre as a last resort where unable to find an alternative centre)
  - a candidate is being taught, prepared, entered or sitting exams where a relevant member of centre staff has a personal connection to the candidate
- Maintains records that confirm the measures taken/protocols in place to mitigate any potential risk to the integrity of the qualifications affected by the above, and where
  - A member of exams office staff have a personal connection to a candidate being entered for exams and assessments at the centre or at another centre
  - A member of centre staff is taking qualification at the centre which does not include internally assessed components/units (taking at the centre as a last resort where unable to find an alternative centre?
  - o A member of centre staff is taking a qualification at another centre
- Ensures other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials are briefed on the requirements for maintaining and integrity and confidentiality of the exam materials

"It is the responsibility of the head of centre that their centre informs the awarding bodies, before the published deadline for entries, of any members of centre staff who are either sitting examinations and assessments or teaching and preparing members of their family (which includes step-family, foster family and similar close relationships) or household for examinations and assessment or where members of their family will be sitting examinations and assessments;

Awarding bodies must be informed where members of the family (which includes stepfamily, foster-family and similar close relationships) of exams office staff are being entered for examinations and assessments; whether by the centre itself or a different centre

Note: Heads of centre must note that entering members of centre staff for qualifications at their own centre must be as a last resort in cases where the member of centre staff is unable to find another centre

The head of centre is responsible for ensuring that proper protocols are in place to prevent the member of centre staff having access to examination materials prior to the examination and that other centre staff are briefed on maintaining the integrity and confidentiality of the examination materials

The head of centre must ensure that during the examination series the member of centre staff is treated as per any other candidate entered for that examination, does not have access to examination materials and does not receive any preferential treatment.

Note: If a candidate is entered for an awarding body's examinations at a centre where a relative is employed, the head of centre must ensure that during the examination series the candidate's relative does not have unaccompanied access to examination materials. For example, question papers, pre-release materials and answer scripts.

If the relative in question is the centre's examinations officer, then appropriate arrangements must be made to ensure that another person is present for all of the administrative arrangements relating to the candidate's examinations. (For example, any application for special consideration must be authorised by a member of centre staff other than the candidate's relative.)"

- Ensures members of centre staff do not forward e-mails and letters from awarding body or JCQ personnel without prior consent to third parties or upload such correspondence onto social media sites and applications
- Ensures members of centre staff do not advise parents/candidates to contact awarding bodies/JCQ directly nor provide them with addresses/email addresses of awarding body examining/assessment or JCQ personnel

"The examinations officer or quality assurance co-ordinator is the person appointed by a head of centre to act on behalf of the centre in matters relating to the administration of awarding body examinations and assessments."

#### **Exams Officer**

- Understands the contents of annually updated JCQ publications including:
   <u>General regulations for approved centres</u>
   <u>Instructions for conducting examinations</u>
   <u>Suspected Malpractice in Examinations and Assessments</u>
   <u>Post-results services</u> (PRS)
- Is familiar with the contents of annually updated information from awarding bodies on administrative procedures, key tasks, key dates and deadlines
- Ensures key tasks are undertaken and key dates and deadlines met
- Recruits, trains and deploys a team of internal/external invigilators; appoints lead invigilators, as required and keeps a record of the content of training provided to invigilators for the required period
- Works with the SENCo to ensure invigilators supervising access arrangement candidates and those acting as a facilitator supporting access arrangement candidates fully understand the respective role and what is and what is not permissible in the exam room
- Supports the head of centre in ensuring that awarding bodies are informed of any Conflict of Interest taken/protocols in place to mitigate any potential risk to the integrity of the qualifications affected before the published deadline for entries

 Briefs other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials on the requirements for maintaining the integrity and confidentiality of the exam materials

# Senior Leaders (SLT)

 Are familiar with the contents, refer to and direct relevant centre staff to annually updated JCQ publications including:

**General regulations for approved centres** 

*Instructions for conducting examinations* 

Access Arrangements and Reasonable Adjustments

Suspected Malpractice in Examinations and Assessments

# Special educational needs co-ordinator (SENCo)

- Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:
  - Access Arrangements and Reasonable Adjustments
- Leads on the access arrangements and reasonable adjustments process (referred to in this policy as 'access arrangements')
- If not the qualified access arrangements assessor, works with the person appointed, on all matters relating to assessing candidates and ensures the correct procedures are followed
- Presents when requested by a JCQ Centre Inspector, evidence of the assessor's qualification

# **Head of Department (HoD)**

- Ensures teaching staff undertake key tasks, as detailed in this policy, within the exams process (exam cycle) and meet internal deadlines set by the EO and SENCo
- Ensures teaching staff keep themselves updated with awarding body subject and teacherspecific information to confirm effective delivery of qualifications
- Ensures teaching staff attend relevant awarding body training and update events

# **Teaching Staff**

- Attend/undertake key tasks, as detailed in this policy, within the exams process and meet internal deadlines set by the EO and SENCo
- Keep updated with awarding body subject and teacher-specific information to confirm effective delivery of qualifications
- Attend relevant awarding body training and update events

# **Invigilators**

- Attend training, update, briefing and review sessions as required
- Provide information as requested on their availability to invigilate
- Sign a confidentiality and security agreement and confirm whether they have any current maladministration/malpractice sanctions applied to them

#### **Reception Staff**

 Support the EO in the receipt and dispatch of confidential exam materials and follow the requirements for maintaining the integrity and confidentiality of the exam materials

#### Site Staff

Support the EO in relevant matters relating to exam rooms and resources

#### **Candidates**

Where applicable in this policy, the term 'candidates' refers to candidates and/or their parents/carers.

# The exam cycle

The exams management and administration process that needs to be undertaken for each **exam series** is often referred to as the **exam cycle** and relevant tasks required within this grouped into the following stages:

- planning
- entries
- pre-exams
- exam time
- results and post-results

This policy identifies roles and responsibilities of centre staff within this cycle. Planning: roles and responsibilities

#### Planning: roles and responsibilities

#### **Information sharing**

#### **Head of Centre**

Directs relevant centre staff to annually updated JCQ publications including <u>GR</u>, <u>ICE</u>, <u>AA</u>, <u>SMEA</u>
 and <u>NEA</u> (and the instructions for conducting coursework)

#### **Exams Officer**

- Signposts relevant centre staff to JCQ publications and awarding body documentation relating to the exams process that has been updated
- Signposts relevant centre staff to JCQ information that should be provided to candidates
- As the centre administrator, approves relevant access rights for centre staff to access awarding body secure extranet sites

# Information gathering

#### **Exams Officer**

- Undertakes an annual information gathering exercise in preparation for each new academic year to ensure data about all qualifications being delivered is up to date and correct
- Collates all information gathered into one central point of reference
- Researches awarding body guidance to identify administrative processes, key tasks, key dates and deadlines for all relevant qualifications
- Produces an annual exams plan of key tasks and key dates to ensure all external deadlines can be effectively met; informs key centre staff of internal deadlines
- Collects information on internal exams to enable preparation for and conduct of GCSE exams

# **Head of Department**

- Responds (or ensures teaching staff respond) to requests from the EO on information gathering
- Meets the internal deadline for the return of information
- Informs the EO of any changes to information in a timely manner minimising the risk of late or other penalty fees being incurred by an awarding body
- Notes the internal deadlines in the annual exams plan and directs teaching staff to meet these

#### **Access Arrangements**

#### **Head of Centre**

- Ensures there is appropriate accommodation for candidates requiring access arrangements in the centre for all examinations and assessments
- Ensures a written process is in place to not only check the qualification(s) of the appointed assessor(s) but that the correct procedures are followed as per *chapter 7 of the JCQ* Publication *Access Arrangements and Reasonable Adjustments*
- Ensures the SENCo is fully supported in effectively implementing access arrangements and reasonable adjustments once approved

#### **SENCo**

- Assesses candidates (or works with the appropriate qualified assessor as appointed by the head
  of centre
- Gathers evidence to support the need for access arrangements for a candidate
- Liaises with teaching staff to gather evidence of normal way of working of an affected candidate
- Determines candidate eligibility for arrangements or adjustments that are centre-delegated
- Gathers signed Personal data consent, Privacy Notices (AAO) and Data Protection
   confirmation forms (candidate personal data consent form) from candidates where required
- Applies for approval through Access arrangements online (AAO), via the Centre Admin Portal (CAP), where required or through the awarding body where qualifications sit outside the scope of AAO
- Keeps a file for each candidate for JCQ inspection purposed containing all the required documentation (if any documentation is kept electronically, in the event of IT failure at the time of an inspection is able to access this documentation in an alternative format)
- Employs good practice in relation to the Equality Act 2010
- Liaises with the EO regarding exam time arrangements for access arrangement candidates
- Ensures staff appointed to facilitate access arrangements for candidates are appropriately trained and understand the rules of the particular arrangement(s) and keeps a record of the content of training provided to facilitators for the required period
- Works with the EO to ensure invigilators and those acting as a facilitator fully understand the respective role and what is and what is not permissible in the exam room
- Provides and annually reviews a centre policy on the use of word processors in exams and assessments

# Word processor policy (exams)

• Ensures criteria for candidates granted **separate invigilation within the centre** is clear, meets JCQ regulations and best meets the needs of individual candidates and remaining candidates in main exam rooms

# **Separate Invigilator within the Centre Policy**

Policy available from Exams Office

#### Senior Leaders, Head of department, Teaching staff

- Support the SENCo in determining and implementing appropriate access arrangements
- Provide a statement for inspection purposes which details the criteria the centre uses to award and allocate word processors for examinations

#### Internal assessment and endorsements

#### **Head of Centre**

- Provides fully qualified teachers to mark non-examination assessments
- Ensures an internal appeals procedure relating to internal assessment decisions is in place for a candidate (or parent/carer) to appeal against and request a review of the centre's marking (see Roles and responsibilities overview)
- Ensures a non-examination assessment policy including the management of controlled assessment is in place for Legacy, new GCSE qualifications which include components of non-examination assessment (For CCEA GCSE centres this would be a controlled assessment policy)

# Non-examination assessment policy

Policy available from Exams Office

 Ensures any irregularities relating to the production of work by candidates are investigated and dealt with internally if discovered prior to a candidate signing the authentication statement (where required) or reported to the awarding body if a candidate has signed the authentication statement

#### **Senior Leaders**

- Ensure teaching staff have the necessary and appropriate knowledge, understanding, skills, and training to set tasks, conduct task taking, and to assess, mark and authenticate candidates' work (including where relevant, private candidates)
- Ensure appropriate internal moderation, standardisation and verification processes are in place

#### **Head of Department**

- Ensures teaching staff delivering GCSE specifications (which include components of nonexamination assessment) follow JCQ <u>Instructions for conducting non-examination assessments</u> and the specification provided by the awarding body
- For other qualifications, ensures teaching staff follow appropriate instructions issued by the awarding body
- Ensures teaching staff inform candidates of their centre assessed marks as a candidate may request a review of the centre's marking before marks are submitted to the awarding body

# **Teaching Staff**

- Ensure appropriate instructions for conducting internal assessment are followed
- Ensure candidates are aware of JCQ and awarding body information for candidates on producing work that is internally assessed (coursework, non-examination assessments, social media) prior to assessments taking place
- Ensure candidates are informed of their centre assessed marks as a candidate may request a review of the centre's marking before marks are submitted to the awarding body

#### **Exams Officer**

- Identifies relevant key dates and administrative processes that need to be followed in relation to internal assessment
- Signposts teaching staff to relevant JCQ *information for candidates* documents that are annually updated

#### **Invigilation**

#### **Head of Centre**

- Ensures relevant support is provided to the EO in recruiting, training and deploying a team of invigilators
- Ensures, if contracting supply staff to act as invigilators, that such persons are competent and fully trained, understanding what is and what is not permissible (and not taking on its own an assurance from a recruitment agency, that this is the case)
- Determines if additional invigilators will be deployed in timed Art exams in addition to the subject teacher

#### **Exams Officer**

- Recruits additional invigilators where required to effectively cover all exam periods/series' throughout the academic year
- Collects information on new recruits to identify if they have invigilated previously and if any current maladministration/malpractice sanctions are applied to them
- Provides a training for new invigilators on the instructions for conducting exams and an annual update for the existing invigilation team so that they are aware of any changes in a new academic year before they are allocated to invigilate an exam (*Using the Exams Office Invigilation Training Programme*)
- Ensures invigilators supervising access arrangement candidates understand their role (and the role of a facilitator who may be supporting a candidate) and the rules and regulations of the access arrangement(s)
- Ensures invigilators are briefed on the access arrangement candidates in their exam room (and that these candidates are identified on the seating place) and confirms invigilators understand what is and what is not permissible
- Collects evaluation of training to inform future events

# **Entries: roles and responsibilities**

# **Estimated entries**

#### **Exams Officer**

 Requests estimated or early entry information, where this may be required by awarding bodies, from HoDs in a timely manner to ensure awarding body external deadlines for submission can be met

# Estimated entries collection and submission procedure

Exams Officer will notify all exam boards of necessary estimated entries and submit via exam board website.

 Makes candidates aware of the JCQ Information for candidates – Privacy Notice at the start of a vocational qualification or when entries are being processed for a general qualification

#### **Head of Department**

- Provides entry information requested by the EO to the internal deadline
- Informs the EO immediately of any subsequent changes to entry information

# **Final entries**

#### **Exams Officer**

- Requests final entry information from HoDs in a timely manner to ensure awarding body external deadlines for submission can be met
- Informs HoDs of subsequent deadlines for making changes to final entry information without charge
- Confirms with HoDs final entry information that has been submitted to awarding bodies
- Ensures as far as possible that entry processes minimise the risk of entries or registrations being missed reducing the potential for late or other penalty fees being charged by awarding bodies

# Final entries collection and submission procedure

Candidates are selected for their exam entries by Heads of Department and the subject teachers.

Candidates, or parents/carers, can request a subject entry, change of level or withdrawal. The request will then be considered by SLT.

The Centre does not accept entries from external candidates.

Entries will be submitted via A2C

# **Head of Department**

- Provides information requested by the EO to the internal deadline
- Informs the EO immediately, or at the very least prior to the deadlines, of any subsequent changes to final entry information, which includes
  - changes to candidate personal details
  - amendments to existing entries
  - withdrawals of existing entries

 Checks final entry submission information provided by the EO and confirms information is correct

#### Entry fees

The Centre will pay all normal exam fees on behalf of candidates.

Late entry or amendments fees are paid by departments.

Candidates or departments will not be charged for changes of tier, withdrawals made by the proper procedures or alterations arising from administrative processes provided these are made within the time allowed by the awarding bodies.

#### **Late entries**

#### **Exams officer**

- Has clear entry procedures in place to minimise the risk of late entries
- Charges any late or other penalty fees to departmental budgets

# Access to scripts, reviews of results appeals procedures

Scripts may be requested by centre staff or candidates if there are reasonable grounds for believing there has been an error in marking.

If a result is queried, the Exams Officer, Teaching Staff and Head of Centre will investigate the feasibility of asking for a re-mark at the centre's expense.

When the centre does not uphold a RoR, a candidate may apply to have an enquiry carried out. If a candidate requires this against the advice of the subject teacher, they will be charged.

Students will be required to complete and sign a Request for Script Form and/or an Reviews about Results and Appeals form. Once completed the Exams Officer will apply for Script or Enquires Appeal.

#### **Return of Papers**

After the release of results, candidates may ask subject staff to request the return of papers.

Centre staff may also request scripts for investigation or for teaching purposes. For the latter, the consent of candidates must be obtained.

GCSE re-marks cannot be applied for once a script has been returned.

"The centre will... have in place written procedures for how it will deal with candidates' requests for access to scripts, clerical checks, reviews of marking, reviews of moderations and appeals to the awarding bodies. Details of these procedures must be made widely available and accessible to all candidates. Candidates must be made aware of the arrangements for post-results services before they sit any examinations and the accessibility of senior members of centre staff immediately after the publication of results..."

[GR 5.13]

"The centre will... treat all candidates equally, including private candidates, throughout the examination process. This would also extend to post-results services and appeals." [GR 5.6]

"Senior members of centre staff must be accessible to candidates immediately after the publications of results so that results may be discussed and decisions made on the submission of enquiries. Candidates must be informed of the periods during which centre staff will be available so that they may plan accordingly." [PRS 4.11]

 Identifies and confirms arrangements for the dispatch of candidate exam scripts with the DfE (STA) 'yellow label service' or the awarding body where qualifications sit outside the scope of the service

 Ensures teaching staff provide estimated grade information to the EO by the internal deadline (where this still may be required by the awarding body)

#### **Exams Officer**

- Submits estimated grade information to awarding bodies to meet the external deadline (where this may still be required by the awarding body)
- Keeps a record to track what has been sent

#### **Exams Officer**

- Ensures that candidates who arrive very late for an exam are reported to the awarding body by submitting a report on candidate admitted very late to examination room through CAP to timescale
- Warns candidates that their script may not be accepted by the awarding body

#### **Invigilators**

- Are informed of the policy/process for dealing with late/very late arrival candidates through training
- Ensure that relevant information is recorded on the exam room incident log

#### Candidate late arrival policy

#### **Conducting exams**

#### **Head of Centre**

• Ensures venues used for conducting exams meet the requirements of JCQ and awarding bodies

#### **Exams Officer**

- Ensures exams are conducted according to JCQ and awarding body instructions
- Uses an exam day checklist to ensure each exam session is fully prepared for, unplanned events
  can be dealt with and associated follow-up is completed

#### **Dispatch of exam scripts**

#### **Exams Officer/Lead Invigilator**

- Dispatches scripts as instructed by JCQ and awarding bodies
- Keeps appropriate records to track dispatch

#### **Exam papers and materials**

#### **Exams Officer/Lead Invigilator**

- Organises exam question papers and associated confidential resources in date order in the secure facility
- Attaches erratum notices received to relevant exam question paper packets
- Collates attendance registers and examiner details in date order
- Regularly checks mail or email inbox for updates from awarding bodies
- In order to avoid potential breaches of security, ensures prior to question paper packets being opened that another member of staff or an invigilator checks the day, date, time subject, unit/component and tier of entry if appropriate, immediately before a question paper packet is opened

- Ensures this additional/second check (which takes place in the secure room if a question paper packet has to be split or in the designated exam room if not) is recorded
- Where allowed by the awarding body, only releases exam papers and materials to teaching departments for teaching and learning purposes after the published finishing time of the exam, or until any timetable clash candidates have completed the exam

#### **Exam rooms**

#### **Head of Centre**

- Ensures that on the day of the exam, relevant internal tests, mock exams, revision or coaching sessions are not conducted in a room 'designated' as an exam room
- Ensures that when a room is 'designated' as an exam room it is not used for any purpose other than conducting external exams
- Ensures only authorised centre staff are present in exam rooms
- Ensures the centre's policy information relating to food and drink that may be allowed in exam rooms is clearly communicated to candidates (via the student exam handbook)
- Ensures the centre's policy on candidates leaving the exam room temporarily is clearly communicated to candidates

#### Food and drink in exam rooms policy

The Head of Centre has ruled that only clear water can be taken into the examination room and must be in a clear bottle with all labels removed. No food is allowed in the examination room unless for medical reasons (i.e. Diabetic) which should be identified prior to the exam session. All food in this case should be in clear bags and without wrappers.

# Policy on candidates leaving the exam room temporarily

Candidate will be escorted from the room and kept under exam conditions by a member of exams office/invigilator. The time will be noted when they leave their desk and again when return on the Examination Report Form.

If a candidate is entitled to rest breaks will be kept under exam conditions by a member of exams office/invigilator. Candidate will be compensated with the time they have been on a rest break at the end of the exam. When a candidate starts their rest break the candidates paper is collected and the time is noted on the Examination Report Form. The candidates paper will be return to them and time noted on the Examination Report Form.

#### **Exams Officer**

- Ensures exam rooms are set up and conducted as required in the regulations
- Provides invigilators with appropriate resources to effectively conduct exams
- Briefs invigilators on exams to be conducted on a session by session basis (including the arrangements in place for any transferred candidates and access arrangement candidates)
- Ensures sole invigilators have an appropriate means of summoning assistance (if this is a mobile phone, instructs the invigilator that this must be on silent mode)
- Ensures invigilators understand they must be vigilant and remain aware of incidents or emerging situations, looking out for malpractice or candidates who may be in distress, recording any incidents or issues on the exam room incident log

- Ensures invigilators understand how to deal with candidates who may need to leave the exam room temporarily and how this should be recorded on the exam room incident log
- Provides authorised exam materials which candidates are not expected to provide themselves
- Ensures invigilators and candidates are aware of the emergency evacuation procedure
- Ensures invigilators are aware of arrangements in place for a candidate with a disability who may need assistance if an exam room is evacuated

#### **Senior Leaders**

- Ensure a documented emergency evacuation procedure for exam rooms is in place
- Ensure arrangements are in place for a candidate with a disability who may need assistance if an exam room is evacuated

# **Emergency evacuation policy**

Policy available from Exams Office

#### **Site Staff**

- Ensure exam rooms are available and set up as requested by the EO
- Ensure grounds or centre maintenance work does not disturb exam candidates in exam rooms
- Ensure fire alarm testing does not take place during exam sessions

#### **Invigilators**

 Conduct exams in every exam room according to JCQ Instructions for conducting examinations and/or awarding boy requirements and as instructed by the centre in training/update and briefing sessions

#### **Candidates**

- Are required to follow the instructions given to them in exam rooms but authorised centre staff and invigilators
- Are required to remain in the exam room for the full duration of the exam

# **Irregularities**

#### **Head of Centre**

 Ensures any cases of alleged, suspected or actual incidents of malpractice or maladministration before, during or after examinations/assessments (by centre staff, candidates, invigilators) are investigated and reported to the awarding body immediately, by completing the appropriate documentation

#### Managing behaviour in exam rooms procedure

The head of centre has the authority to remove a candidate from the examination room, but should only do so if the candidate would disrupt others by remaining in the room.

If a candidate is being disruptive, the invigilator must warn the candidate that he/she may be removed from the examination room.

The candidate must also be warned that the awarding body will be informed and may decide to penalise them, which could include disqualification.

The invigilator will record the incident.

#### **Senior Leaders**

- Ensure support is provided for the EO and invigilators when dealing with disruptive candidates in exam rooms
- Ensure that internal disciplinary procedures relating to candidate behaviour are instigated, when appropriate

#### **Exams Officer**

- Provides an exam room incident log in all exam rooms for recording any incidents or irregularities
- Actions any required follow-up and reports to awarding bodies as soon as practically possible after the exam has taken place

#### **Invigilators**

 Record any incidents or irregularities on the exam room incident log (for example, late/very late arrival, candidate or centre staff suspected malpractice, candidate illness or needing to leave the room temporarily, disruption or disturbance in the exam room, emergency evacuation)

#### **Special consideration**

#### **Exams Officer**

- Processes appropriate requests for special consideration to awarding bodies
- Gathers evidence which may need to be provided by other staff in centre or candidates
- Submits requests to awarding bodies to the external deadline

#### Special consideration policy

Policy available from Exams Office

#### **Candidates**

Provide appropriate evidence to support special consideration requests, where required

# **Unauthorised materials**

#### Arrangements for unauthorised materials taken into the exam room

- Any unauthorised items that have been taken into the examination room must be placed out of reach of the candidates (and not under their desks) before the examination starts. This would normally be at the front of the examination room or a similar arrangement that enables the invigilator to control access to the items.
- The invigilator, prior to the examination starting, must ensure that candidates have removed their wrist watches, placing them on their desks.

Are informed of the arrangements through training

# Internal exams

#### **Exams Officer**

- Briefs invigilators on conducting internal exams
- Returns candidate scripts to teaching staff for marking

#### **Invigilators**

Conduct internal exams as briefed by the EO

#### Results and post-results: roles and responsibilities

#### **Internal assessment**

# **Head of Department**

- Ensures teaching staff keep candidates' work, whether part of the moderation sample or not, secure and for the required period stated by JCQ and awarding bodies
- Ensures work is returned to candidates or disposed of according to the requirements

#### Managing results day(s)

#### **Senior Leaders**

- Identify centre staff who will be involved in the main summer results day(s) and their role
- Ensures senior members of staff are accessible to candidates after the publication of results so
  that results may be discussed and decisions made on the submission of any requests for postresults services and ensures candidates are informed of the periods during which centre staff
  will be available so that they may plan accordingly

#### **Exams Officer**

Works with senior leaders to ensure procedures for managing the main summer results day(s)
 (a results day programme) are in place

# Results day programme

- Results will be available on Results day 27 August 2021 from 9.00am until 10.30am.
- Results will be printed off and placed in a sealed envelope addressed to the candidate along with details regarding Review of Results in the letter enclosed with results
- Results must be signed for by the candidate or with written confirmation from the candidate by parents/carers.

#### **Site Staff**

 Ensure the centre is open and accessible to centre staff and candidates, as required for the collection of results

# **Accessing results**

#### **Head of Centre**

Ensures results are kept entirely confidential and restricted to key members of staff until the
official dates and times of release of results to candidates

#### **Exams Officer**

 Informs candidates in advance of when and how results will be released to them for each exam series.

- Accesses results from awarding bodies under restricted release of results, where this is provided by the awarding body
- Resolves any missing or incomplete results with awarding bodies
- Issues statements of results to candidates on issue of results date
- Provides summaries of results for relevant centre staff on issue of results date

#### **Post-results services**

#### **Head of Centre**

- Ensures an internal appeals procedure is available where candidates disagree with any centre
  decision not to support a clerical re-check, a review of marking, a review of moderation or an
  appeal
- Understands that if the centre has concerns about one of its component/subject cohorts, then
